DECLARATION OF KIMBERLY K. NESS REGARDING SETTLEMENT ADMINISTRATION EXPENSES

2. JND is serving as the Settlement Administrator¹ in the above-captioned litigation ("Action") for the purposes of administering the Joint Stipulation and Settlement Agreement preliminarily approved by the Court in its Order Preliminarily Approving Class Action Settlement ("Order"), dated February 3, 2022. I previously submitted the declaration to confirm the mailing of the Short-Form Notice and the posting of the Long-Form Notice on the Website, dated March 18, 2022. I am submitting this declaration to report on the Settlement Administration Expenses that JND has incurred for this matter and to provide an update on JND's estimated remaining Settlement Administration Expenses.

3. Settlement Administration Expenses includes all Class Notice and administrative fees, costs, or expenses incurred in administering the Settlement. As of March 18, 2022, JND has incurred \$49,661.66 in Settlement Administration Expenses.
